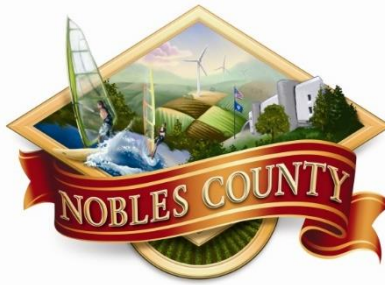

NOTICE OF INFORMATIONAL LAND OWNER MEETINGS AND FINAL HEARING FOR REDETERMINATION OF BENEFITS FOR NOBLES COUNTY DITCHES BBC 1, CD 2, CD 4, CD5, CD6, and CD30
