

**NOTICE OF HEARING ON VIEWERS' REPORT  
IN THE MATTER OF THE REDETERMINATION OF BENEFITS

The Nobles County Drainage Authority Board for County Ditch NO 6 finds as follows: that a proceeding has been commenced for the redetermination of benefits and damages and benefited areas and damaged areas of Nobles County, County Ditch NO 6; that said proceeding is now pending; that the Viewers appointed herein have made and filed their report in the office of the Nobles County Auditor-Treasurer.
