

**NOTICE OF HEARING ON VIEWERS' REPORT
IN THE MATTER OF THE REDETERMINATION OF BENEFITS
NOBLES COUNTY, JUDICIAL DITCH NO 11B**

The Nobles County Drainage Authority Board for Judicial Ditch No. 11B finds as follows: that a proceeding has been commenced for the redetermination of benefits and damages and benefited areas and damaged areas of Nobles County, Judicial Ditch No. 11B; that said proceeding is now pending; that the Viewers appointed herein have made and filed their report in the office of the Nobles County Auditor-Treasurer.

The Nobles County Drainage Authority Board for Judicial Ditch No. 11B establishes: **Monday December 20 at 9:30 a.m.** (*Wednesday December 22 at 9:30 a.m. in case of weather event*), at the **Worthington Event Center (1447 Prairie Drive, Worthington, MN 56187) in the Grand Ballroom Room** as the time and place to hear and consider the Viewer's Report; and that all persons interested in the redetermination of benefits and damages and benefited and damaged areas of Nobles County, Judicial Ditch No. 11B, are invited to appear and be heard by the Nobles County Drainage Authority Board, at that time, for or against the proposed proceeding and with respect to any other matters in connection with it.
