Issue:

With the release of the census numbers and the State Redistricting Plan, Nobles County will need to approve a redistricting plan for the county by April 26, 2022. Prior to approving the plan, a public hearing must take place on the plan options and we are required to publish the notice for the hearing three weeks prior to the hearing.

The hearing can take place as part of a regular board meeting or may be set at a different time. Following the schedule from the last redistricting calendar, our hearing should take place on April 5th of 2022 to allow enough time for a continuation if needed. At this point, we are waiting for final confirmation from all voting districts that they will be reestablishing their current boundaries and if no changes are made, it will allow the county to do the same. The public hearing will give citizens the option of submitting a plan for the board to consider if they want changes made to the current county commissioner district boundaries.

Draft Notice of the Hearing Notice

Notice is hereby given that on Tuesday, the 5th day of April, 2022, at 11:00 a.m. the Nobles County Board of Commissioners will hold a public hearing at the Nobles County Government Center, 315 10th Street, in the City of Worthington, for the purpose of considering any and all preliminary plans submitted for the redistricting of Nobles County Commissioner Districts. A copy of any submitted preliminary plans with all attachments and support documentation shall be available for public inspection at www.co.nobles.mn.us or in the Administration Office of the Government Center during regular office hours of 8:00 a.m. to 4:30 p.m., Monday through Friday starting April 1st, 2022. Any citizen intending to submit a plan for consideration in the redistricting of Nobles County Commissioner Districts must do so no later than noon on March 31st, 2022.

Notice is also given that the Nobles County Board of Commissioners will meet in the Board Room of the Nobles County Government Center, 315 10th Street, in the City of Worthington on April 5th, 2022 at 11:00 a.m., for the purpose of adopting a resolution for redistricting or re-establishing current district boundaries of the Nobles County Commissioner Districts.
