OVERVIEW

Jackson & Nobles County Judicial Ditch No. 13 (JD 13) lies within in Sections 13-16, 19-29, and 32-36 of Lorain Township and Sections 1-2 and 5 of Indian Lake Township in Nobles County, and Sections 18-20, and 29-36 of Ewington Township, Sections 1-6 and 9-14 of Round Lake Township, and Sections 7 and 18 of Sioux Valley Township. While Nobles & Jackson County Judicial Ditch No. 9 (JD 9) lies within Sections 1-4, 9-12 of Indian Lake Township of Nobles County and Section 5, 6 and 7 of Round Lake Township of Jackson County. The projects were broken into 11 different bid packages, which 7 bid packages for JD 13 and 4 bid packages for JD 9.

Construction has started and completed on 4 out of the 6 bid packages that have started. Bid Packages 1, 2 and 3 of JD 13 and Bid Package 1 of JD 9 are the 4 completed bid packages. Below is a description of each bid package.

JD 13 - Bid Package #1

Bid Package 1 of Judicial Ditch No. 13 consisted of the main open ditch cleaning and tree removal from Section 30 of Ewington Township to Section 7 of Sioux Valley Township. The contractor for the bid package was Noomen Excavating LLC.

JD 13 – Bid Package #2

Bid Package 2 of Judicial Ditch No. 13 consisted of the retention pond on the Riley property in Section 2 of Round Lake Township. The contractor for the bid package was Reker Construction and Aggregate.

JD 13 – Bid Package #3

Bid Package 3 of Judicial Ditch No. 13 consisted of proposed tile branches V, W, KK, KK1, WW, WW3, WW4 and WW5 all within Jackson County. All of the Work was within Section 29, 30, 32 of Ewington Township as well as Section 3 and 4 of Round Lake Township. The contractor for the bid package was Loo Con Inc.

JD 9 – Bid Package #1

Bid Package 1 of Judicial Ditch No. 8 consisted of proposed tile main from JD 13 to JD 9 open ditch as well as Branch Z, Z1, Z3, and Z7. The contractor for the bid package was Hodgman Drainage Company Inc.
